## 5. Financial report

#### 5.1 Present financial report

Rich Easton gave the financial report for the financial year 1st April 2021 to 31st March 2022, which covered:

- Summary of funding for research, almost \$8M, with \$5M in research grants and \$2M for renewal of Chair of Clinical Neurology
- The funding to support researchers impacted by COVID-19, over \$500,000 during the financial year and almost \$1.5M since COVID-19 started
- A note that the Annual Impact report (printed version) did not have audited financials as
  Deloitte (the Foundation's auditors) were unable to start on time due to COVID-19 impact
  on resourcing
- The financial audit has been completed and approved by the Foundation's Council and has been lodged with Charities Services, following an extension granted by them
- Summary of the financial position:
  - Commitment of over \$7.78M to research
  - o Income of \$6.79M, of which \$3.37M was from beguests
  - A loss of \$615K on the investment portfolio due to extreme market challenges globally on the investment sector
  - Operating expenditure held steady at \$2.55M which included the Foundation's education, awareness and fundraising activities
  - The transfer of over \$80M of investments to Mercer
- · Some highlights from the year
  - o Continuation of 50th anniversary celebrations
  - Growth in digital webinars
  - More Supporter / Donor engagement over phone / video calling to reduce COVID-19 risks
  - A new fundraising database
  - o 8 months of working remotely due to COVID-19
  - First iteration of our Statement of Service Performance, which the Foundation will be audited on next year
- Thank you messages to
  - o Chair and Council and the Committees for their time volunteered to help Foundation
  - o Experts globally who help peer review applications
  - The research community
  - The Neurological Foundation team
  - o The Foundation's supporters, without whom none of this could happen

# 8. Research committee update

#### 8.1 SAC & PAC reports

Scott Graham provided a summary of the Scientific Advisory Committee (SAC) and Personal Awards Committee (PAC) for the year, which covered:

- Growth in the volume of applications to both Committees for review, and the Committee members dedication in reviewing this increased load
- An increasing trend from the Foundation on the funding available to support neurological research
- The success rates for grant applications to the Foundation in the range of 20 25%, compared to other similar funding bodies such as Health Research Council or Marsden who fund around 8% of applications
- Growth in the number of Fellowships & Scholarships offered and the corresponding work to interview all candidates
- A healthy growth in the number of research lab groups throughout New Zealand, which has direct links to the support the Foundation provides to the research community
- And, as always, the challenge of being able to fund all the quality requests for funding received
- A big thank you to the PAC & SAC Committees for their work, to the Council for their support and approval and to the Foundation's team, in particular the Research area led by Sarah Schonberger
